**TERMS OF USE:** All Ethernet cabling runs must use CAT5 (or above). It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, indoor cabling requirements, and Dynamic Frequency Selection (DFS) requirements.

## Installation Requirements

- Phillips screwdriver (for rack or wall mounting)
- Standard-sized, 19" wide rack with a minimum of 1U height available (for rack mounting)
- For indoor applications, use Category 5 (or above) UTP cabling approved for indoor use.
- For outdoor applications, shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the power supply.

We recommend that you protect your networks from harmful outdoor environments and destructive ESD events with industrial-grade, shielded Ethernet cable from Ubiquiti Networks. For more details, visit [www.ubnt.com/toughcable](http://www.ubnt.com/toughcable)

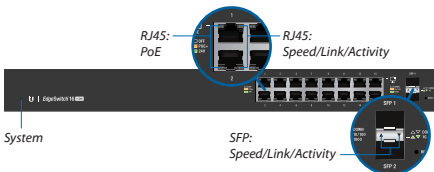

Reset	<p>There are two methods to reset the EdgeSwitch to factory defaults:</p> <p><b>Runtime Reset (Recommended)</b></p> <p>The EdgeSwitch should be running after bootup is complete, and the <i>System LED</i> is white. Press and hold the <b>Reset</b> button. The EdgeSwitch will reboot, and the <i>System LED</i> becomes blue after three seconds. Continue to hold the <b>Reset</b> button for about 15 seconds until the <i>System LED</i> flashes blue for two seconds. This indicates that the EdgeSwitch has reset to its factory defaults.</p> <p><b>Power-on Reset</b></p> <ol style="list-style-type: none"><li>1. Disconnect the <i>Power Cord</i> from the EdgeSwitch.</li><li>2. While connecting the <i>Power Cord</i> to the EdgeSwitch, hold the <b>Reset</b> button for about 15 seconds until the <i>System LED</i> flashes blue for two seconds. This indicates that the EdgeSwitch has reset to its factory defaults.</li></ol>

Use an RJ45-to-DB9, serial console cable, also known as a rollover cable, to connect the <i>Console</i> port to your computer. Then configure the following settings as needed:</p> <ul style="list-style-type: none"><li>• <i>Baud rate</i> 115200</li><li>• <i>Data bits</i> 8</li><li>• <i>Parity</i> NONE</li><li>• <i>Stop bits</i> 1</li><li>• <i>Flow control</i> NONE</li></ul>

## Hardware Installation

The EdgeSwitch can be placed on a horizontal surface, mounted in a rack, or mounted on a wall.

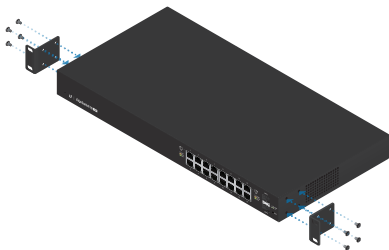
Place the *Rubber Feet* on the bottom of the EdgeSwitch if you do not plan to mount it. For rack or wall mounting, follow the appropriate steps:

## Rack Mounting

1. Attach the *Mount Brackets* to the EdgeSwitch using the eight *Bracket Screws*, positioning the brackets as shown below.

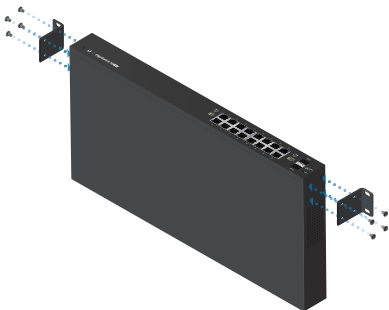


2. Attach the EdgeSwitch to the rack using the four *Mounting Screws*. (If the rack has square slots, then use the *Cage Nuts* with the *Mounting Screws*.)

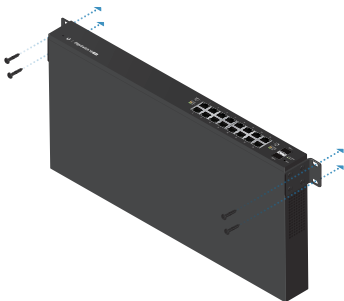


## Wall Mounting

1. Attach the *Mount Brackets* to the EdgeSwitch using the eight *Bracket Screws*, positioning the brackets as shown below.



2. Secure the EdgePower to the wall using the appropriate fasteners and anchors (not included) for the wall.



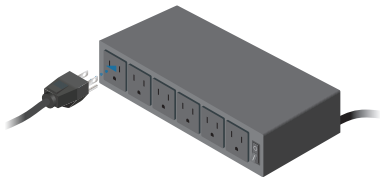


## Connecting Power

1. Connect the *Power Cord* to the *Power* port of the EdgeSwitch.



2. Plug the *Power Cord* into a power outlet.

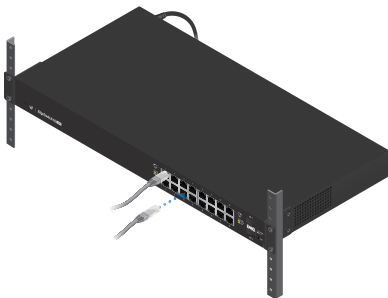


## Connecting Ethernet

1. Connect an Ethernet cable from your computer or host system to any Ethernet port on the EdgeSwitch.



2. Connect Ethernet cables from your devices to the other Ethernet ports on the EdgeSwitch.



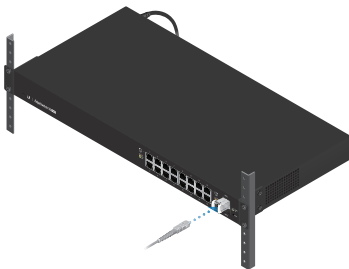
## Using SFP Ports

To use an *SFP* port:

1. Remove the protective plug covering the *SFP* port.
2. Plug a compatible fiber module into the *SFP* port.



3. Connect the fiber optic cable to the fiber module. Then connect the other end of the cable to another fiber device.

## Accessing the Configuration Interface

By default, the EdgeSwitch will try to get its IP address automatically using DHCP. If that fails, then it will use the default fallback IP address, *192.168.1.2*. Proceed to the appropriate section, *DHCP* or *Fallback IP Address*:

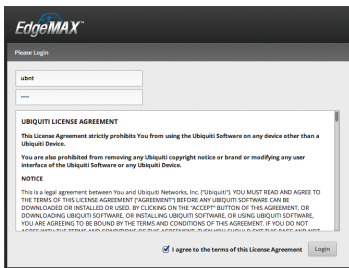
### DHCP

Use one of the following methods:

- Set up the DHCP server to provide a specific IP address to the EdgeSwitch based on its MAC address (on the label).
- Let the EdgeSwitch obtain an IP address and then check the DHCP server to see which IP address was assigned.

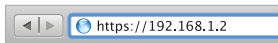
1. Launch your web browser. Type the appropriate IP address in the address field. Press **enter** (PC) or **return** (Mac).

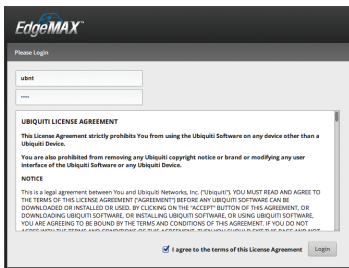

## Fallback IP Address


1. Ensure that your computer (or other host machine) is connected to the EdgeSwitch.
2. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
3. Launch your web browser. Type the appropriate IP address in the address field (192.168.1.2 is the default fallback IP address). Press **enter** (PC) or **return** (Mac).



4. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.




5. The EdgeSwitch Configuration Interface will appear. Go to **System > Connectivity > IPv4**.
